## Personal data we process:

## Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect information about website visitors who are under 16 years of age, unless they have permission from parents or guardians. #### **For what purpose and based on what basis we process personal data:**

DPP BV processes your personal data for one or more of the following purposes (partly depending on which services or functionalities you use):

- To send you our newsletter and/or advertising leaflet
- To be able to call or email you if necessary to perform our service
- To inform you about changes to our services and products
- To deliver goods and services to you and to handle your payment
- To analyze your behavior on the website so that we can improve the website and tailor the range of products and services to your preferences
- DPP BV also processes personal data if we are legally obliged to do so, such as information we need for our tax returns.

#### **Automated decision-making**

DPP BV does not take decisions based on automated processing on matters that may have (significant) consequences for individuals.

#### **How long we keep personal information**

DPP BV does not keep your personal data any longer than is strictly necessary to realize the purposes for which your data is collected. This means that we keep the data as long as it is necessary to deliver the service you have requested. Apart from this, some data we have to keep longer because the law obliges us to do so.

#### **Sharing of personal data with third parties**

DPP BV does not sell your information to third parties and will only provide it if necessary to carry out our agreement with you or to comply with any legal obligation. With companies that process your data in our mission, we conclude a processors agreement to ensure the same level of security and confidentiality of your data. DPP BV remains responsible for these processing.

#### **Cookies, or similar techniques, which we use**

DPP BV uses only technical and functional cookies. and analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone on the first visit to this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They make sure that the website works properly and, for example, remember your preference settings. We can also optimize our website. You can opt out of cookies by setting your Internet browser to not store cookies. In addition, you can also delete any information previously saved through your browser's settings.

#### View, modify, or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to revoke your consent to data processing or to object to the processing of your personal data by DPP BV and you have the right of data portability. This means that you can submit a request to us to send the personal data that we have from you in a computer file to you or another organization. You may send a request for inspection, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to [info@dpp-pultrusion.com](mailto:info@dpp-pultrusion.com).

In order to ensure that the request for inspection has been made by you, we ask you to send a copy of your identity document with the request. In this copy, make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number black. This to protect your privacy. We respond as quickly as possible, but within four weeks, at your request.

#### How we protect personal information

DPP BV takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unsolicited disclosure and unauthorized alteration.
